### Standards Review Teams Collaborate, Begin Drafting Process

The ACCJC Standards Review process continued over the summer as the Peer Writing Teams convened and began their work. All five teams are having robust dialogue about expectations for quality, equitable outcomes, and continuous improvement in their content area. Team members are also thinking deeply about how the new Standards will be used, and are prioritizing clear language and reducing redundancies as they draft initial language. Teams will continue to meet through the fall semester, with the intent of meeting the goals outlined in the [tentative timeline](#).

### Available Now: Updated *Guide to Institutional Self-Evaluation*

ACCJC continues to update its guides and manuals. The latest edition of the *Guide to Institutional Self-Evaluation, Improvement, and Peer Review* is now available on the ACCJC website. The [Guide to Institutional Self-Evaluation, Improvement, and Peer Review](#) contains suggestions for how an institution organizes for self-evaluation and prepares for peer review. It is intended for use by institutions as they prepare their Institutional Self-Evaluation Report (ISER) and by teams when assessing institutions. The September 2021 edition of the *Guide* has been streamlined and reorganized for better usability. The contents have also been updated where needed to reflect current practices - for example, a section about ACCJC's new two-semester comprehensive review process has been added.
