Subject: Invitation for Member Comments on Proposed Changes to ACCJC Policies

The ACCJC Policy Committee oversees the development of new policies and changes to existing policies.

Commission procedures generally provide that proposed policy changes and/or new policies be considered

by the Commission in a two-meeting process. At the first meeting, new policies/policy changes are discussed

and modifications are made as appropriate (first-reading). These policies are then circulated to ACCJC's member

institutions and other interested parties for review and comment before presentation at the next scheduled

Commission meeting for second-read and adoption.

At its January 2018 meeting, the Commission considered the following policy changes for firstread:

1. Policy on Contractual Relationships with Non-Regionally Accredited Organizations – this policy has

been revised to narrow the policy focus on contracts regarding for-credit educational programming.

 Policy on Substantive Change – the policy was reviewed by the Commission's Substantive Change Committee as part of their regular review of the Substantive Change Manual. Language has been

added to define an institution's new location as a "permanent" location. Minor edits were also done for clarity.
